

Twin Kennels Stud Service

Terms and Conditions

Both parties agree that all paperwork required in this document will be supplied to the applicable parties. It is also understood and agreed that the Stud Dog Owner has the right to refuse to breed listed stud if any of the paperwork submitted by Breeder does not meet the requirements of the Owner.

It is also agreed and understood by both parties that any and all money, paper work, pictures or requirements that are not sent in a timely manner or not met, will be considered breach of this contract and thus, Stud Owner has no obligation to sign the applicable litter registration papers until requirements are met by the Breeder, or vice-versa.

DAM OWNER(S) Terms and Conditions

The Dam Owner(s) understands and agrees to these Terms and Conditions

- Written veterinary certification that the female listed has been tested negative for BRUCELLOSIS within thirty (30) days prior of the breeding.
- Current vet examination clearing the female listed from any bacterial diseases that may be present to cause venereal diseases or problems with conceiving.
- Legible copy of the AKC registration certificate of the female listed.
- Legible copy of her pedigree
- Proof of current vaccinations
- If the female fails to be in whelp (pregnant) the DAM OWNER(S) must give notice no later than sixty-five (65) days after the date of mating. A repeat stud service will be provided for no additional charge to the same female in her next season, or another female with approval of Stud Owner, under the same terms of this Contract in the event that one or more do not result from this breeding.
- It is guaranteed that if one or more puppies are born alive or, it's considered to be a litter. The STUD OWNER is then released from this contract.
- If only one puppy is born dead a repeat stud service will be provided for no additional charge to the same female in her next season, or another female with approval of Stud Owner, under the same terms of this Contract in the event that one or more do not result from this breeding.
- That the female listed will not be bred to any other male dog during her heat cycle, other than the stud listed and that utmost care will be taken to ensure that she is not bred to any other male before/after stud service has been provided.
- Dam owner(s) are responsible for providing ALL food while in the Stud Owners care.
- Understands that every precaution will be taken to ensure against disease, injury, accident, loss, or death of the female listed. If veterinary care is needed at any time while the female is in Stud Dog Owner`s care, the DAM OWNER(S) is expected to meet Stud Dog Owner at the VET (will call the Dam Owner and inform them). Stud Dog Owner is not held responsible for any of the above occurrences.
- The stud fee for this breeding is to be paid on/before the time the breeding female arrives at the Stud Dog Owner's residence. ALL STUD FEES ARE NON-REFUNDABLE!!!!
- If something should happen to the female (injury, illness, loss or death) during the pregnancy no refunds will be given.
- The stud dog will attempt to service the female at least two times. In the event that the female cannot be bred naturally, Breeder may request that the female be artificially inseminated. If such is the case, Stud Dog Owner Stud Dog Owner's Veterinarian (London Veterinarian Clinic) to have the female artificially inseminated. The Dam Owner will be responsible for all costs involved with this.

STUD OWNER Terms and Conditions

The Stud Owner understands and agrees to these Terms and Conditions

- STUD OWNER reserves the right to refuse stud service if the female listed is not: AKC registered, deaf, not sound in temperament and appears unhealthy or in poor conditions.
- To kennel the visiting female in a safe environment with all necessary precautions. Every precaution will be taken to ensure against disease, injury, accident, loss, or death of the female. However, STUD DOG OWNER will not be held responsible for any injury or loss to the female if any should occur.
- The Stud Dog Owner warrants that no other dog but the stud listed will be introduced or bred to the listed female. Special care and attention will be provided to ensure against any accidental breeding while the female is in residence of the Stud Dog Owner.
- The stud dog will attempt to service the female at least two times. In the event that the female cannot be bred naturally, Breeder may request that the female be artificially inseminated. If such is the case, Stud Dog Owner will ask the Dam Owner to take the female at their Veterinarian of their choice (London Veterinarian Clinic) have the female artificially inseminated. The Dam Owner will be responsible for all costs involved with this procedure.
- Should stud listed die, or become unable to sire a litter, the owner of the stud retains the right to grant a free service to another of their studs.
- Stud Dog Owner will provide Breeder with exact dates of ties of each breeding that occurs. Is not liable or responsible for any expenses incurred in association with the breeding.
- STUD OWNER(S) reserve(s) the right to charge a boarding fee at the rate of \$7.00 per day, after the seventh (7th) day.
